Celebrating the End of a Decade and Saddling Up to Ride into a New One!

As we saddle up and get ready to ride into the new decade beginning with 2010, we would like to take time to reflect on our growth and acknowledge all who have helped us make it to this point. There have been many changes since the Mounted Eagles opened its doors in 1992. The biggest being that we have grown in numbers from the beginning three riders and one horse to ending 2009 by serving 68 riders with as many as nine horses at one time. That might not seem like a lot of growth in 17 years but when you realize that we only have 20 hours per week to provide services to our riders, that's quite a growth spurt! We have also grown in the number of faithful volunteers that help us each week to deliver therapeutic horsemanship lessons and activities to these riders. We have a staff of over 50 volunteers who work at the barn, on the Board of Directors or behind the scenes doing administrative duties. Our seven program horses work tirelessly to carry their precious cargo and do their part in helping to strengthen bodies and souls. Without these volunteers and our dedicated horses, we could not provide the services that we do to the special people of

Rider of the Fourth Quarter - Cody Vleck

Cody Vleck is a 10-year old energetic young man who doesn't let the fact that he has Spina Bifida slow him down one bit, especially at the barn. Cody is riding into his 4th year with the Mounted Eagles Therapeutic Horsemanship program. For years he has faced several gross motor challenges, including walking and maintaining general body balance. Since Cody has been riding horses, he has been able to stand on one leg and skip. Yea Cody! Cody has improved steadily in his riding skills and with this improvement his confidence has taken a huge leap as well. He is one of our smallest (in stature) riders but it does not stop him from riding our largest horse. He took riding Tamarack on as a challenge when she came to be part of our horse family. Cody has helped her learn to work in the way that we need her to handle our special equestrians and he reminds her that she needs to listen to more subtle cues than she was used to. While teaching Tamarack to listen to his cues, Cody has strengthened his arm, torso and leg muscles as well as increased his ability to focus intently for a long period of time. He has also taken on the challenge of another new arrival, this time a much smaller model. Butter is a pony and is about 1/2 the size of Tamarack. While Cody walks beside Butter holding her with a lead rope, she has to pay special attention to his pace and her

position in relation to him so as not to bump him. With the volunteers very close at hand, he is doing a good job of showing Butter the ropes on how to become a successful Mounted Eagles horse. Cody worked hard to get ready for this fall's horse show and did himself proud earning ribbons in each of the three events in which he participated. Beyond riding, Cody loves the outdoors. His favorites are hunting and fishing with his dad and their annual family camping trip to the Boundary Waters Area of Minnesota. Cody is always a joy to be around. He is serious about his "horse training" duties and practices his riding skills with great tenacity. He walks in ready for work and walks out with a "hi five" for all and ready to face his next challenge.


Year-End Financial Report

2009 was a tough year financially for a lot of individuals, businesses and, especially, for the non-profit sector. Funding from grantors was cut back and the criteria for receiving funding were streamlined drastically. These cutbacks and changes affected Mounted Eagles quite severely. Because we are a small program and serve a smaller population we did not meet the new 'number of people' served for some of our former grantors' guidelines. We serve individuals from five counties and are almost maxed out on our 20 hours of available facility time that we now have. At this time, we cannot afford to pay for more barn time. If we could get more funding, we could lease more time--without more time we can't serve many more people--without more people we can't meet the guidelines. It's a Catch 22 situation. We ended the year in a big deficit and are going in to 2010 with a smaller reserve than we have had in a number of years. We, however, know that what we are doing is important and it is in God's hands that we will succeed. We are blessed with donors who care and give as they can. We will succeed and we will continue to be here because of those of you who care and who continue to help those who are less fortunate. God Bless You All!


